



BlackRock Capital Investment Corporation Announces Departure of Chief Financial Officer and Appoints New Interim CFO

NEW YORK--(BUSINESS WIRE)--Oct. 24, 2017-- BlackRock Capital Investment Corporation (or "BCIC") (NASDAQ:BKCC) today announced that Donna Milia, Chief Financial Officer for BlackRock Capital Investment Corporation, has decided to leave BCIC for personal reasons. Ms. Milia has agreed to remain with BlackRock Advisors, LLC, BCIC's investment advisor, through December 29, 2017.

Michael Pungello, Co-Head of BlackRock's Global Alternatives Operations group assumed the interim CFO position effective October 20, 2017. Mr. Pungello is a member of BlackRock Business Operations as part of Global Fund Administration. Mr. Pungello is familiar with the accounting and operations of BCIC due to his position at BlackRock as well as his involvement in both the transaction leading up to BlackRock's purchase of BlackRock Kelso Capital as well as the integration following the March 2015 acquisition. In addition to his interim CFO duties, Mr. Pungello is also responsible for administrative support for various alternative products including hedge funds, hedge fund of funds, and private equity funds.

Mr. Pungello's service with the firm dates back to 1998, including his years with Merrill Lynch Investment Managers (MLIM), which merged with BlackRock in 2006. Prior to moving to his current role in 2006, Mr. Pungello was the Chief Financial Officer for Merrill Lynch Alternative Investments. Previously he was the Director of Finance, Global Operations, and Technology. He began his career in 1979 at Deloitte & Touche where he was a Partner responsible for securities and investment company practices.
